Financial Reports 2019 and 2020

ASOR National has continued to operate separate accounts from the ASOR chapters for the 2019 and 2020 years. As has been the case from 2018, these reports have not been audited and financial reports have not been submitted to the ACT regulator. ASOR National has continued to not levy capitation against the branches and its direct funds are depleting. ASOR National's principal source of income has been profits from the ASOR-MODSIM conferences, the last of which, 2019, included cost to support an international speaker and so ran at a loss to the society. A large expense during 2020 was associated with the constitutional change process. During 2020, ASOR National took possession of ASOR Canberra funds for safe keeping.

These points are all described in more detail below.

Reporting only ASOR National

ASOR National holds and manages approximately one quarter to one third of all the funds within ASOR as a whole. This is because most of the funds and income are managed by the respective state branches and/or chapters. This makes consolidated reporting difficult or near impossible so these reports will continue the practice of reporting only ASOR National's finances. In particular this report does not include the position of active or inactive branches. Constitutional reform should make the management of financial affairs much easier as they will all be consolidated.

These reports are not audited

ASOR National's last audited accounts were in 2017 and it was determined that it was inappropriate to continue with the current auditor beyond then. Noting that ASOR National averages 23 transactions per year, with 12 of those being interest payments, and that a low priced alternate auditor could not be found, the treasurer decided to not seek auditing and to carry over transactions for a potentially unified audit once constitutional consolidation has occurred. To that end, the accounts include provisions each year for a future audit.

Constitutional reform will make auditing easier as only one entity will need auditing, rather than requiring separate audits for National and each of the branches/chapters.

ASOR financial reports have not been filed with the ACT regulator since 2017

ASOR has not been filing its annual returns with the ACT corporations' office (Access Canberra) from 2017 onwards. This is partly due to the absence of audited and consolidated accounts. Again, it is envisaged that subsequent to constitutional change, ASOR will bring its corporate affairs into order and so allowances for filing fees have been made in the 2018-2020 accounts.

ASOR National's only main income is conferences

After 2015, the ASOR National Committee decided not to seek capitation from constituent branches/chapters. Thus, ASOR National has been slowly running down its funds, with occasional income bursts from successful ASOR-MODSIM conferences, with \$770 and \$4,956 being received from the 2015 and 2017 conferences respectively. The 2019 National conference was run at a net estimated loss to ASOR of \$3,642 due to the society's support for an international plenary speaker (see below).

Given the rate of spend, the available funds specifically attributable to ASOR National are \$6,049, so it is unlikely that ASOR National could continue to operate in its current form for more than one year. That is, if constitutional change is not enacted and the current model of running separate accounts to the state branches and not collecting capitation from those branches continues.

ASOR National is now holding some chapter balances

ASOR National has been holding the defunct Sydney Chapter balance in its accounts since 2009. In 2020, ASOR National took possession of the Canberra Chapter balance in anticipation of constitutional change, and in order to relieve the chapter of the burden of financial management given their limited membership and activities.

Following the successful ASOR-MODSIM conference in 2013, ASOR National took possession of the conference proceedings (\$12,850) on behalf of the inactive South Australian branch. In 2017, following a member consultation period, this amount was formally assumed into ASOR National operating funds. There is still a SA bank account, however it is understood that no current ASOR National or ASOR Victoria members have access to it.

ASOR-MODSIM 2019 profits are yet to be fully realized

ASOR invited Professor Gerald Brown from NPS to be a plenary speaker at ASOR-MODSIM 2019 and undertook to cover Prof. Brown's expenses. It was expected that these costs would be offset by the funds that would eventually return to ASOR, namely the conference profit attributed to ASOR and the plenary speaker's fee. Professor Brown's expenses were recognized in the 2019 ASOR accounts, however Prof. Brown was reimbursed by ASOR Victoria and ASOR National has yet to transfer funds to ASOR Victoria for this amount, again in anticipation of constitutional change.

The MODSIM organizers are holding onto to the ASOR monies from ASOR-MODSIM2019 as ASOR's contribution to funding the 2021 conference. The ASOR National Treasurer has yet to receive formal notification of this and the amounts involved and so these monies have been recognized only as allowances (estimates) in the 2020 ASOR National accounts.

Constitutional Change has been a substantial investment

In order to undertake constitutional change, and at the strong recommendation of Science and Technology Australia/FASTS, the ASOR National Committee authorized ASOR to become a member of <u>The Associations Forum</u> in 2019. This entitled ASOR to some amount of free governance advice and a constitutional review. Subsequent to this, in 2020 ASOR engaged The Associations Forum to work with us to draft a new constitution, and to prepare explanatory documentation. The combined cost of this membership for 2019 and 2020 was \$1,988 and the total cost of consultancy services was \$9,570 in 2020.

The 2019 conference proceeds amount are an allowance only, an estimate of profit from MODSIM 2019 plus Gerald Brown speaker's fee. This amount will be kept by MODSIM organisers to provide ASOR contribution of initial funds needed to stage MOSIM 2021.
- 3. Proceeds from the 2013 conference was allocated to the SA Chapter and is held by National for that chapter. As the chapter has not been functioning since 2013, the committee assumed the SA Conference balance into ASOR National operating funds following a notice period in which no objections were received.
- 4. In 2020, ASOR received \$259 in royalty payments from the Copyright Agency. In 2019, the Australian Mathematical Sciences Council (AMSC) was wound up and member organisations were given a share of the remaining funds based on current membership numbers.
- 5. These organisations are IFORS (\$USD108), STA/FASTS (\$660), and The Associations Forum (\$1050). The Associations Forum was joined to help facilitate constitutional reform at the recommendation of STA.

- 6. ASOR National agreed to be responsible for the costs of the ASOR invited speaker for MODSIM 2019. This amount has been paid by ASOR Melbourne and ASOR National should pay this amount back to ASOR Melbourne once MODSIM profits have been determined and distributed.
- 7. The Rising Star award is \$1000 and the Best Student Paper award is \$250. As there was no conference in 2020, only the Rising Star award will be given and the decision process for this award is yet to complete. In 2017 there were medal engraving fees.
- 8. In 2018 ASOR sponsored 2 attendees to Science Meets Parliament.
