**The first of the ASOR National newsletters**

While for some this might appear like just one more ASOR newsletter sent to members of the ASOR Melbourne chapter, it is in fact the first newsletter that we will be circulating to all members of ASOR nationally. From now on – especially once we get warmed up – it will incorporate news and event information from all of ASOR. The key motivation for “going national” is that it helps ASOR provide a consistent level of connection, benefits and services to members, in every city and state.

**ASOR Melbourne AGM**

The ASOR Melbourne Annual General Meeting was held on Wednesday 19 March at 5pm in the Access Grid Room at RMIT, and was followed by a seminar given by Melih Ozlen from RMIT.

The main function of the AGM was to elect a new committee (for April 2014 to March 2015). The ASOR Melbourne chapter currently covers not only Melbourne, but for the time being at least, members in SA and NSW. For this reason, we called for committee representatives from outside of Victoria.

Under normal circumstances, the committee has a maximum of 12 elected members, including five "executive" positions (Chair, Vice-Chair, Secretary, Treasurer, and Student Representative). With the two newly-defined roles/responsibilities (SA (Adelaide) Events Liaison, and NSW (Newcastle) Events Liaison), as well as some potential changing-of-the-guard in the next couple of years, the 2013 committee decided to propose to the AGM that up to 17 members be elected to the committee for 2014. The motion was passed at the AGM, and as 17 nominations were received for the committee, the only voting required was to separate the two nominees for the Vice Chair position.

Following the AGM, our monthly Vic/SA/NSW seminar was delivered by Dr Melih Ozlen from RMIT, who discussed recent developments in multi objective mixed/integer/linear programming. Amongst the many interesting insights from this talk, most clear was that there is significant work that is ongoing in this area (including, by Melih and his collaborators, as well as by the Newcastle OR team), and that numerical experiments reported so far in publications have (in the main) so far failed to thoroughly compare competing/complimentary approaches to the various classes of these multi-objective problems.

#### *Collaboration with Access Grid*

On February 26th, some of our Queensland members participated remotely in the Health Systems Modelling Workshops 2014, hosted by the Florey Institute and ASOR. This was achieved using the Access Grid facilities at QUT, linking into an Access Grid room at RMIT. The seminars were of particular value to our attendees, providing a broad coverage of health systems modelled using discrete-event, system dynamics and agent-based modelling. We look forward to more opportunities to collaborate with our interstate ASOR communities via Access Grid in the future.

#### *Tropofy Workshop*

ASOR QLD and the Decision Science Discipline (QUT) jointly organised the workshop "Tropofy – A Platform for Problem Solvers" on 19 Nov 2013. Tropofy is a web deployment platform for quantitative decision making. It utilises the python programming language (framework) and enables the deployment of problem solving apps to the cloud. Extensive web development knowledge or experience is not required to use Tropofy. The primary advantage of Tropofy is that an app can be implemented in any language and run on any platform. (see <http://www.tropofy.com/>). Tropofy may make it easier for the implementation and deployment of OR projects. It is free for academic use and may help the research community to showcase their works.

Abstract: We discuss applications of dynamic hierarchical state space models for sales of competing products, and use them to examine advertising wear, interference, and decay dynamics (Bass et al 2008, Naik et al 1998, Braun and Moe 2013). A significant advance of this model involves the use of matrix normal distributions (Landim and Gamerman 2000, Neelameghan and Chintagunta 2004). This allows us to parsimoniously examine a wide range of cross effects in promotions, advertising and pricing. We examine two applications: retailer promotions for durable products, and television advertising for fast moving consumer goods.

## ASOR Ren Potts Medal and New Researcher Encouragement Award

These prestigious awards were instigated within ASOR many years ago, were regularly awarded in the past, but were unfortunately overlooked in 2011 and again in 2013. These awards will be restored in 2014 and the ASOR National Committee is making plans to award them bi-annually. To this end, the National Committee is now encouraging queries and nominations.

### ASOR Ren Potts Medal

The Ren Potts Medal of the Australian Society for Operations research is intended to recognise individuals who have made outstanding contributions to theory or practice of OR in Australia. It is a national award restricted to Australian residents only.

### ASOR New Encouragement Award

The ASOR New Encouragement Award is intended to recognise new researchers who have completed a research degree at Master or PhD level in OR, or in a related field with significant contribution to the advancement of OR from any Australian university. Normally candidates will be considered who completed all requirements for their degree in the preceding 12 months.

## Mailing list and website changes

In conjunction with the newsletter becoming national, the ASOR National committee is planning to re-launch the ASOR website and all our mailing lists in the near future.

For the website, we are planning for a unified national site that will use the content management system that is already being used by the ASOR

Brisbane Chapter. All of the ASOR website content would migrate into a layout that is very similar to that of the current ASOR Brisbane pages.
